Winners will be determined by the first three (3) ducks to pass the finish line. In the event that the race cannot be conducted, winners will be determined via random drawing.

Proceeds will benefit SVDP Family Kitchen, a program of Food for Families, Inc.

## Official Rules:

The person's name appearing on the ticket corresponding to the first ducks in order of finish will be awarded prizes (first, second, third and last place). The winning ducks will be announced at the conclusion of the event. The winners are not required to be present and will be notified by telephone and /or mail. Winners are required to provide proper identification. If a winner does not come forward to claim the prize won within 30 days following the race, that prize will be forfeited and FFF will declare another winner for that prize. Prizes awarded to minors will be awarded to their parents or legal guardian.
